5. All items must be handcrafted or of local origin, no Taiwan tool booths, food or drink vendors or items that might be deemed as offensive such as drug paraphernalia or nudity items.

7. Vendors must provide their own tent and/or tables. (10 x 10 space)
8. The HCSAC will not supply electricity.
9. **NO FOOD or DRINKS may be sold at this event without written permission by the HCSAC! The HCSAC will be the ONLY entity selling drinks!**
